However, any candidate appearing for more than one (1) Examination (s) may be accommodated on the same day, on a case to case basis, if requested.

- 4. Kindly note that the last date for registration along with the receipt of the requisite fee in order is March 18, 2019 (Monday) and no further extension will be granted. Result will be communicated by FPSB India to the students over email after one week, and corresponding certificate/s will be issued, else the status shall be duly communicated to FPSB Ltd., US.

The candidates are required to bring to the test centre any of their government issued ID proof in original having a clear photograph along with a clear colour photocopy of the same duly self-attested, for submission, with a note written in one's own handwriting, the purpose of the submission along with details. The same shall be subsequently handed over to FPSB Ltd., US as part of the Transition Process.
